No. 2250.- "THE PUBLIC EMERGENCY ENACTMENT, 1914."

In exercise of the powers vested in him by section 17 of "The Public Emergency Enactment, 1914," the High Commissioner has made the following **Regulations**:

1. These Regulations may be cited as "The Aliens Restriction Short title. (Seamen) Regulations, 1916.

2. In these Regulations-

"Alien" includes every person who is not a subject of the Ruler of any of the Federated Malay States or of His Britannic Majesty.

3. (i) An alien, being the master or a member of the crew of a Provisions with respect to vessel arriving at any port or place in the Federated Malay States to alien seamen. applied, shall not land at such port or place unless he has in his possession a passport issued to him not more than two years previously by or on behalf of the Government of the country of which he is a subject or a citizen, or some other document satisfactorily establishing subject or a citizen, or some other document satisfactorily establishing his nationality or identity, to which passport or document there must be attached a photograph of the alien to which it relates.

(ii) Where an alien is, under the provisions of these Regulations, (1) Where an alien is, under the provisions of these Regulations, prohibited from landing at any port or place, the Harbour Master of such port or place or, if there be no Harbour Master, such other officer as the Chief Secretary may appoint in that behalf, may nevertheless grant him temporary permission to land for such purposes and subject to such conditions as the Chief Secretary may from time to time prescribe, either generally or as regards any particular port or place or vessel.

4. Every alien to whom these Regulations apply who shall act in Penalty. 4. Every alien to whom these Regulations apply who shall act in contravention of section 3 (i) or who, having received temporary permission to land, shall fail to observe any condition imposed upon him under section 3 (ii), shall be liable, upon conviction before the Court of a Magistrate of the First Class, to a fine not exceeding the sum of \$1,000 or to imprisonment of either description for a term not exceeding six months, or to both.

Persons abetting or harbouring,

5. Every person who shall abet any alien in any contravention of these Regulations, or knowingly harbours any alien who he knows or has reasonable ground for supposing to have acted in contravention of these Regulations, shall be liable, upon conviction before the Court of a Magistrate of the First Class, to a fine not exceeding the sum of \$1,000 or to imprisonment of either description for a term not exceeding six months, or to both.

6. Any person who acts in contravention of these Regulations, or is reasonably suspected of having so acted or being about so to act, may be taken into custody by any port officer or police constable.

Commence 7. These Regulations shall come into operation on the first day of ' August, 1916.
