#### HONOURS.

No. 152.—His Majesty the King-Emperor has been graciously pleased to confer the honour of Knighthood on Gerald Aubrey Goodman, Esquire, k.c., Chief Judicial Commissioner, Federated Malay States.

No. 153:—His Majesty the King-Emperor has been graciously pleased to appoint John Robert Innes, late Acting Chief Judicial Commissioner, Federated Malay States, to be a Companion of the Most Distinguished Order of Saint Michael and Saint George.

No. 154.—The Food Control Regulations, 1918.—

In exercise of the powers conferred upon him by regulation 6 of the Food Control Regulations, 1918, and of all other powers enabling him in that behalf, the Food Controller hereby orders as follows:

(1) All rice owned by or in the possession, order, or disposition of the Government Rice Mill at Bagan Serai, Krian, in the State of Perak, and the entire future output of rice from the said mill shall on and after the 15th January, 1920, be held at the disposal of the Food Controller.

(2) All such rice shall be taken over by the Food Controller who will communicate from time to time the price which he will be prepared to pay for the same.

No. 155.—The Food Control Regulations, 1918.—

In exercise of the powers conferred upon him by No. 10 of the Food Control Regulations, the Food Controller hereby revokes the order published as Notification No. 4112 in the *Gazette* on 10th October, 1919, whereby maximum prices were fixed for the sale of all rice in the distributing centre of Kuala Selangor.

No. 156.—The Food Control Regulations, 1918.

In exercise of the powers conferred upon him by regulation 10 of the Food Control Regulations, 1918, and of all other powers enabling him in that behalf, the Food Controller hereby amends the order published as Notification No. 3431 in the *Gazette* on September 4th, 1919, by deleting the word "Klang" from the list of distributing centres mentioned in the schedule thereto.

No. 157.—The Food Control Regulations, 1918.—

MAXIMUM PRICES FOR PARBOILED AND WHITE RICE, ULU SELANGOR AND ULU LANGAT.

In exercise of the powers conferred upon him by regulation 6 of the Food Control Regulations, 1918, and of all other powers enabling him in that behalf, the Food Controller hereby fixes maximum prices, as per schedule annexed, for the sale of all white rice and all parboiled rice imported into or milled in the administrative districts of Ulu Langat and Ulu Selangor in the State of Selangor.

IN THE DISTRIBUTING CENTRES OF KLANG AND KUALA SELANGOR.

1. By licensed importers and wholesale dealers in rice ... \$13.20 per picul

2. By licensed retail dealers in rice ... ... ... 14 cents per catty or 84 cents per gantang

When sold outside the above-mentioned distributing centres nothing whatsoever shall be added to the above prices except a sum equal to the net amount of the charges for transport actually incurred by the seller and approved by the Food Controller.

The price at which all rice is sold shall be conspicuously posted at every place at which such sale is made.

Any person disobeying this order will be liable on conviction to a fine not exceeding \$800 and to imprisonment of either description which may extend to six months.
