No. 1707.—The Food Control Regulations, 1918.—

In exercise of the powers conferred upon him by regulation 6 of the Food Control Regulations, 1918, and of all other powers enabling him in that behalf, the Food Controller hereby orders as follows:

Gazette Notification No. 1160, published in the Federated Malay States Government Gazette of 16th March, 1920, fixing maximum prices for Australian wheat flour, is hereby rescinded.

No. 1708.—The Food Control Regulations, 1918.—

In exercise of the powers conferred on him by regulation 6 of the Food Control Regulations, 1918, and of all other powers enabling him in that behalf the Food Controller hereby orders as follows:

1. No person shall directly or indirectly sell by retail or offer for sale by retail any of the brands of milk hereafter mentioned at a price exceeding the amount set against each such brand:

2. No wholesale dealer shall directly or indirectly sell or offer for sale to retailers any of the brands of milk hereinafter mentioned, delivery of which is to be taken at the sellers' godown, at a price exceeding the amount set against each such brand:

- 3. For the purposes of this Order the following expressions used herein shall have the following meanings:
 - "Wholesale Dealer" shall mean any person, firms, chops, or companies specified respectively in the schedules A, B, C, and D to this Order.
 - "Retailer" shall mean any person, firm, chop or company who in the ordinary way of business sell milk
 - "Case" as applied to any particular brand of milk shall mean a case containing the same number of tins of milk as a case of that particular brand now contains.
 - "Tin" as applied to any particular brand of milk shall mean a tin containing the same quantity of milk as a tin of that particular brand now contains.
- 4. Every retailer of milk shall, provided he has sufficient stocks of such milk in his possession, sell at a price not exceeding the price fixed by the Food Controller such milk as any person may require him to sell provided that such retailer shall not be required to sell to any person a greater quantity of milk than is required for a normal consumption.
 - 5. (i) This Order may be cited as the Price of Milk Order No. 3 of 1920.
 - (ii) This Order shall apply generally throughout the Federated Malay States.
 - (iii) This Order shall have effect as from 1st May, 1920.
- (iv) The Price of Milk Order No. 1 of 1919, published as Notification No. 955 in the Gazette on 5th March, 1919, is hereby cancelled in so far as it relates to Nestle's Milkmaid Sterilised Natural and the Price of Milk Order Nos. 1 of 1920 and 2 of 1920 published as Notifications 597 and 949 in the Gazette on 6th February, 1920, and 8th March, 1920, are hereby cancelled.
