No. 6288.—The Chief Secretary to Government records with deep regret the death of Mr. A. J. Weller, Chief Inspector of English Schools, Federated Malay States and Straits Settlements, which occurred in Kuala Lumpur on the 5th October, 1922.

"THE QUARANTINE AND PREVENTION OF DISEASE ENACTMENT, 1903."

No. 6289.—Information having been received that a dangerous infectious or contagious disease—namely smallpox—exists in Calcutta it is hereby declared by the Resident of Selangor, in exercise of the powers conferred on him by Rule 2 of the Rules made under "The Quarantine and Prevention of Disease Enactment, 1903," that the Port of Calcutta is an infected place for the purposes of the said Rules.

No. 6290.—Information having been received that a dangerous infectious or contagious disease—namely plague—exists in Rangoon it is hereby declared by the Resident of Selangor, in exercise of the powers conferred on him by Rule 2 of the Rules made under "The Quarantine and Prevention of Disease Enactment, 1903," that the Port of Rangoon is an infected place for the purposes of the said Rules.

No. 6291.—Swine fever having ceased to exist among pigs in the district of Seremban, Negri Sembilan, the Resident of Pahang rescinds Gazette Notification No. 3208 of the 26th May, 1922, prohibiting the importation of pigs from Negri Sembilan into Pahang.

No. 6292.—Foot-and-mouth disease having ceased to exist among cattle, sheep and goats in the district of Seremban, Negri Sembilan, the Resident of Pahang rescinds Gazette Notification No. 4693 of the 3rd August, 1922, prohibiting the importation of cattle, sheep and goats from Negri Sembilan into Pahang.

No. 6293.—PRICE OF RUBBER.—

With reference to Notification No. 5778, published in the Federated Malon States Government Gazette of the 24th November, 1921, it is hereby notified that the price of rubber for the assessment of duty for the period 13th October to 19th October, 1922, inclusive, is twenty-four and three-fourth cents per pound, this being two cents below the highest price obtained for first grade rubber at the Singapore auction during the week ending 5th October, 1922.
