"THE EXPORT OF RUBBER (RESTRICTION) ENACTMENT, 1922."

No. 6295.—Provisional Licences to Export. (Dealers).—

As the export of rubber from the Federated Malay States, except under licence, will be prohibited with effect from the 1st November, 1922; and as the small-holders' coupons will not have been completely issued by that date; licensed rubber dealers will be given provisional licences to export without coupons. The provisional licences will be valid from the 1st to 14th November only. Application must be made by the licensed dealer to the District Officer accompanied by a declaration under the "Statutory Declarations Enactment, 1899," relative to the dealers' average monthly exports of rubber, with full particulars of his name, address and licence number. The quantity mentioned in the provisional licence will be 60 per cent. of one-half the dealer's average monthly exports.

When coupons are available for the rubber exported under a provisional licence, the licensed dealer will have to produce coupons to cover the quantity of rubber exported by him under the provisional licence.

No. 6296.—Provisional Licences to Export. (Planters).—

As the export of rubber from the Federated Malay States, except under licence, will be prohibited with effect from the 1st November, 1922, estate managers who export their rubber direct from the estate are requested to apply to the District Officer for a provisional licence to export rubber. This will be issued to them, upon demand, pending the preparation and issue of a "Certificate of Standard Production." The provisional licence will be valid for the month of November only; and will cover a quantity which is a provisional estimate of 60 per cent. of the standard Production of the estate for one month. Upon the issue of a Certificate of Standard Production, the quantity of rubber exported under the provisional licence will be deducted from the quantity exportable at the minimum rate under the Certificate of Standard Production.

Estate managers must supply the District Officer with all the information requisite for the issue of a provisional licence. (Subject to certain exceptions, standard production means the actual output during the period November, 1919-October, 1920, and estate managers will facilitate the issue of their provisional licences if they supply this information at the time of making the application.).

Further instructions will issue with regard to applications for Certificates of Standard Production.

This notice does not apply to persons who sell their rubber to dealers in the Federated Malay States, nor does it apply to licensed rubber dealers.

Separate instructions will issue in regard to provisional licences for licensed rubber dealers.
