"THE CUSTOMS ENACTMENT, 1920."

CUSTOMS DUTIES.

No. 6639.—In exercise of the powers vested in him by section 5 (i) of "The Customs Enactment, 1920," the Chief Secretary cancels with effect from 24th October, 1922, Notification No. 3728, published in the *Gazette* of the 8th August, 1921, and the import duties imposed thereby, and imposes in the stead thereof import duties upon the articles mentioned in Table A hereto appended at the rates therein severally specified:

TABLE A.

Description of article.	Duty.
A. Arrack, brandy, whisky, rum, gin, and any other intoxicating liquors not hereinafter provided for	\$10.00 per proof gallon
Provided that the duty on brandy, whisky, rum and gin imported in bottle and accepted by the Proper Officer of Customs as not exceeding 81 per cent. of proof spirit shall be	7.20 per gallon
B. Japanese Saki and Chinese samsu including medicated samsu	9.00 per proof gallon
C. Bitters and liqueurs not exceeding 100 per cent. of proof spirit	10.00 per gallon
D. Sparkling wines not exceeding 42 per cent. of proof spirit	4.50 ..
E. All still wines (including medicated wines) not exceeding 42 per cent. of proof spirit, excepting claret of a strength not exceeding 30 per cent. of proof spirit	3.00 ..
F. Claret of a strength not exceeding 30 per cent. of proof spirit, ale, beer, stout, porter, cider and perry	.90 ..

Definitions: In this table the words "intoxicating liquors", "liquor", "medicated wines" and "gallon" have the meaning assigned to them in "The Excise Enactment, 1915."

"Proof spirit" means a liquid containing 49.24 per cent. by weight of alcohol and 50.76 per cent. by weight of distilled water, and having a specific gravity at 60° Fahrenheit of .91984.

"Proof gallon" means a gallon of proof spirit. A duty payable on any liquor "per proof gallon" means a duty payable upon the maximum number of proof gallons which the alcohol contained in such liquor, when mixed with water, is capable of forming.
