1. In accordance with section 8 of the Public Officers' Guarantee Fund Enactment, No. 11 of 1913, we have the honour to report on the financial position of the Fund for the year ending 31st December, 1923.

2. The entrance fees amounted to \$585 and contributions to \$9,051 as compared with \$833 and \$10,929 for 1922.

3. The interest received on the investments during the year was \$6,312.

4. At the end of the year the Fund stood security for 7,200 officers to the amount of \$3,625,580.
