REPORT OF THE DIRECTORS OF THE PUBLIC OFFICERS' GUARANTEE FUND, FEDERATED MALAY STATES, FOR THE YEAR 1913.

1. In accordance with section 8 of "The Public Officers' Guarantee Fund Enactment," we have the honour to report on the financial position of the Fund for the year ended 31st December, 1913.

2. The entrance fees amounted to \$1,479.50 and contributions to \$9,269.42 as compared with \$1,314.12 and \$8,283.11 of 1912.

3. The interest on investments was \$3,270.68 as against \$2,920.41 of 1912. The increase is owing to the amounts of some of the deposits being increased from cash balances. The total interest earned on investments to end of 1913 amounted to \$20,712.04, which is \$10,359.11 in excess of the total sum paid on account of defalcations.

4. At the end of the year the Fund stood security for 3,603 officers to the amount of \$1,787,216.
