No. 539.—His Excellency the Governor of the Straits Settlements and High Commissioner for the Malay States having left Singapore on the 25th March, 1922, for the Federated Malay States, the following instrument, passed under the Public Seal of the Colony, constituting and appointing the Honourable FREDERICK SETON JAMES, Companion of the Most Distinguished Order of Saint Michael and Saint George, to be from the 25th March, 1922, his Deputy during his absence from the Settlement, is published for general information:—

SIR LAURENCE NUNNS GUILLEMARD, KNIGHT, COMMANDER OF THE MOST HONOURABLE ORDER OF THE BATH, GOVERNOR AND COMMANDER-IN-CHIEF OF THE STRAITS SETTLEMENTS AND THEIR DEPENDENCIES, TO THE HONOURABLE FREDERICK SETON JAMES, COMPANION OF THE MOST DISTINGUISHED ORDER OF SAINT MICHAEL AND SAINT GEORGE.

GREETING:—

WHEREAS I am about to proceed to the Federated Malay States on the 25th March, 1922:

NOW KNOW YOU that I do by these presents, under and by virtue of the powers and authorities in that behalf given to me by certain Letters Patent under the Great Seal of the United Kingdom of Great Britain and Ireland, bearing date the 17th February, 1911, constitute and appoint you, the said FREDERICK SETON JAMES, to be my Deputy within the Straits Settlements during my absence from Singapore and in that capacity to exercise, perform and execute for me and on my behalf, during such absence, all such of the powers and authorities by the said Letters Patent or otherwise vested in me, including the right to preside at all Meetings of the Executive and Legislative Councils, as I have powers to delegate and assign to a Deputy:

PROVIDED always that these presents shall not affect the exercise by myself of any of the powers or authorities now vested in me and that you shall in the discharge of the office of Governor's Deputy conform to and observe all such instructions as I have already or shall hereafter address to you for your guidance.

This guidance does not confer upon you precedence over any other officer.

GIVEN at Singapore, this 25th day of March, 1922, under the hand of His Excellency the Governor and the Public Seal of the Colony.
