"THE LABOUR CODE, 1912."

It is hereby notified that, in exercise of the powers conferred by section 156 of "The Labour Code, 1912," the Indian Immigration Committee has, with the consent of the High Commissioner, prescribed the rate payable under section 156 (a) of the said Enactment to be \$2 per quarter for the 2nd and 3rd quarters of the year 1914.

No further rate under section 156 (b) of the said Enactment is prescribed in respect of the said two quarters.

No. 516.—RINDERPEST.—Rinderpest having ceased to exist in the State of Johore, the Resident of Negri Sembilan hereby rescinds Notification No. 2673, published in the *Gazette* of the 13th September, 1913.

No. 517.—RINDERPEST.—It is notified that Notification No. 3028, published in the *Gazette* of the 24th October, 1913, prohibiting the importation of cattle into the State of Pahang from the State of Johore, by land or by sea, is hereby rescinded.
