No. 1188.—"The Banishment Enactment, 1.10."—Authority to Delegate Powers vested by Law in the Secretary for Chinese Affairs.—By virtue of the power conferred upon him by section 3 of "The Banishment Enactment, 1910," the Secretary for Chinese Affairs has appointed the officer for the time being acting in the post of Assistant Protector of Chinese, Negri Sembilan, to be the officer in Negri Sembilan who, in his absence from the State, shall submit to the Resident such written informations as are referred to in the before-mentioned section.

No. 1189.—Order under Rule 77 of the Rules under "The Quarantine and Prevention of Disease Enactment, 1903."—Whereas information has been received that foot-and-mouth disease exists among cattle in the district of Lipis, the Resident of Pahang hereby prohibits until further notice the movements of cattle, other than bullocks in carts, within the limits of the above-named district, except with the permission of the Government Veterinary Surgeon or Veterinary Inspector.

"SECRETARY FOR CHINESE AFFAIRS ENACTMENT, 1899" (PERAK).

AUTHORITY TO EXERCISE POWERS VESTED BY LAW IN THE SECRETARY FOR CHINESE AFFAIRS.

Under the provisions of section 32 of the "Secretary for Chinese Affairs Enactment, 1899" (Perak), the Secretary for Chinese Affairs, with the sanction of the Chief Secretary to Government, hereby authorizes the under-mentioned officer to exercise the powers vested in him by law as follows:

Mr. A. D. Ball, Acting Assistant Controller of Labour, Ipoh, to exercise the following powers under the "Secretary for Chinese Affairs Enactment, 1899" (Perak)—viz.:

- (i) The powers of examination and the other powers incidental thereto vested in the Secretary by section 2 (ii) and (iii) and sections 3 and 4 of the said Enactment;
- (ii) The powers to appear in Court in certain cases vested in the Secretary by section 6 of the said Enactment;
- (iii) The power of directing photographs to be taken vested in the Secretary by section 34 of the said Enactment; and
- (iv) All powers vested in the Secretary by the "The Women and Girls Protection Enactment, 1902."

"SECRETARY FOR CHINESE AFFAIRS ENACTMENT, 1899," AS AMENDED BY "THE SECRETARY FOR CHINESE AFFAIRS ENACTMENT, 1899, AMENDMENT ENACT-MENT, 1901" (SELANGOR).

AUTHORITY TO EXERCISE POWERS VESTED BY LAW IN THE SECRETARY FOR CHINESE AFFAIRS.

Under the provisions of section 32 of the "Secretary for Chinese Affairs Enactment, 1899," the Secretary for Chinese Affairs, with the sanction of the Chief Secretary to Government, hereby authorizes the under-mentioned officer to exercise the powers vested in him by law as follows:

Mr. J. V. G. Mills, Acting Assistant Controller of Labour, Kuala Lumpur, to exercise the following powers under the "Secretary for Chinese Affairs Enactment, 1899"—viz.:

- A. (i) The powers of examination and the other powers incidental thereto vested in the Secretary by section 2 (ii) and (iii) and sections 3 and 4 of the said Enactment;
 - (ii) The powers to appear in Court in certain cases vested in the Secretary by section 6 of the said Enactment;
 - (iii) The powers in respect of arbitrations and enquiries wested in the Secretary by sections 7 to 13 inclusive of the said Enactment;
 - (iv) The powers in respect of enquiries in cases of intestacy vested in the Secretary by section 17 of the said Enactment;
 - (v) The powers of directing photographs to be taken vested in the Secretary by section 34 of the said Enactment;

and, with the approval of the Resident previously obtained, and in the absence of the Protector from the State, the following powers viz.:

- B. (i) The powers in respect of disputes as to the custody or guardianship of women and children, and as to adoption and betrothal vested in the Secretary by section 14 (i) and (iii) of the said Enactment;
 - (ii) The powers in respect of women who leave the protection and control of their husbands vested in the Secretary by section 15 of the said Enactment;
 - (iii) The powers in respect of women who leave the protection of their lawful guardians vested in the Secretary by section 16 of the said Enactment; and
 - (iv) All powers vested in the Secretary by "The Women and Girls Protection Enactment, 1902."
