No. 1696.—Order under Rule 77 of the Rules under "The Quarantine and Prevention of Disease Enactment, No. 13 of 1903."—Whereas it appears to the Resident of Selangor that a contagious and infectious disease—viz., rinderpest—exists among cattle in the Kuala Selangor district, it is hereby ordered that the following roads are closed to cattle traffic until further notice:

- (1) The Klang-Kuala Selangor road, between the 25th mile and Kuala Selangor town.
- (2) The Rawang-Kuala Selangor road, between the 48th mile and the junction with the Klang-Kuala Selangor road.

All cattle within the area so prescribed are to be kept confined in sheds, and all movements of cattle into, out of, or within the prescribed area are hereby prohibited.
