TENDERS INVITED.

LICENCES TO OPEN TODDY SHOPS, KUALA LANGAT DISTRICT.

Tenders are invited for licences to open toddy shops, for the consumption of toddy on the premises only, subject to the provisions of "The Excise Enactments Amendment Enactment, 1912," in either of the localities named below for the period 1st July to 30th September, 1914.

2. Not more than one licence will be issued for each of these following localities :
 - (1) 6th mile, Klanang ;
 - (2) Simpang Morib.
3. A separate tender must be sent in for each of the above licences.
4. Each tender must state the monthly amount the tenderer is prepared to offer for the licence, and must specify the premises in respect of which a licence is desired.
5. The licensee will be required to pay in advance the monthly amount agreed upon for the licence and also a monthly licence fee of \$1.50, but no licence will be issued until the premises to be licensed have been approved by the Licensing Officer.
6. The licence will be for three months only unless cancelled in accordance with the provisions of section 20 (ii) of the Excise Enactment.
7. Sealed tenders, marked on the outside "Tenders for Toddy Shop Licence," should be addressed to the District Officer, Kuala Langat, and will be received not later than noon on the 22nd June, 1914.
8. Each tender must be accompanied by a deposit of \$50 as a guarantee of good faith. Such deposit will be forfeited in case of failure by the successful tenderer to take up the licence tendered for. Deposits will be returned to unsuccessful tenderers.
9. Successful tenderers will be required to give cash security equal to twice the amount tendered per month for the licence.
10. The Government does not bind itself to accept the highest or any tender.
